WHEREAS, the recognition u/s 14 (3) (a) of NCTE Act, 1993 was granted to the institution namely JRS College of Education, Annamangalam-621102, Veppamtjattai Taluk, Perambalur District, Tamilnadu vide order No. F. TN/SEC/SRO/NCTE/2005-2006/4065 dated 17.11.2005 for conducting Secondary (B.Ed.) Course of one-year duration with an annual intake of 100 students from the academic session 2005-2006.

- 2. AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution has submitted affidavit dated 22.01.2015 for its willingness & adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 31.03.2015 for conducting B.Ed. Programme of two years duration with an annual intake of 100 (two basic units) from the academic session 2015-16.
- 3. AND WHEREAS, the institution submitted written representation on 26.10.2016 requesting for reduction of strength from 2 units to 1 unit in its B.Ed. course. Accordingly, order for reduction of strength from 2 units to 1 unit is sued on 12.09.2017.
- 4. AND WHEREAS, the matter regarding compliance by the institutions of the conditions of the revised recognition order, was placed before the SRC in its 369th meeting held on 28.01.2019 and the committee decided that Show Cause Notice be issued to all such institutions which have not submitted compliance. Accordingly, Show Cause Notice issued on 20.06.2019.
- 5. AND WHEREAS, the SRC in its 380th meeting considered the matter and decided to issue Final SCN u/s 17 of the NCTE Act issued to the institution to submit its representation/reply to the observation noted by the Regional Committee. Accordingly, a Final Show Cause Notice was issued to the institution on 04.02.2020. The institution submitted reply to the Final Show Cause Notice on 25.02.2020.
- **6. AND WHEREAS,** the SRC in its 404th Meeting held on 16th & 17th November, 2021 considered the matter and decided to withdraw the recognition. Accordingly, as per decision of SRC a withdrawal order No.F.SRO/NCTE/APS04146 /B.Ed/TN/2021/129349 was issued to the institution on 01.12.2021.
- 7. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order No. 89-132/E-253985/2022 Appeal/7th Meeting, 2022 Appeal No.APPLSRC202214360 dated

- AND WHEREAS, the SRC in its 415th meeting held on 03rd and 04th November 2022 considered the matter and committee decided to issue Final Show Cause Notice. Accordingly, as per decision of SRC a Final Show Cause Notice was issued to the institution on 17.11.2022. the institution has submitted reply of FSCN vide letter dated 26.11.2022.
- AND WHEREAS, the SRC in its 417th meeting held on 1st and 2nd December 2022 9. considered the matter and decided as under:-

"The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, decided that the continuation order be issued to the Institution JRS College of Education, Survey No. 1339/2, 2B, New Survey No. 638, 638/2, at Annamangalam Village & Panchayat,-621102, Veppamtjattai Taluk, Perambalur District, Tamilnadu for B.Ed. programme, 1 basic units of 50 students.

The Committee further decided that the above said decision will be subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR)."

- NOW THEREFORE, this order is issued permitting the institution i.e. JRS College 10. of Education, Survey No. 1339/2, 2B, New Survey No. 638, 638/2, at Annamangalam Village & Panchayat,-621102, Veppamtjattai Taluk, Perambalur District, Tamilnadu run by Jesi Educational Society, Annamangalam, Perambalur District, Tamilnadu for continuation of recognition for B.Ed. Programme for two-years duration with an annual intake of (1 basic unit) of 50 students subject to the outcome of writ petition pending before the Hon'ble High Court of Delhi in respect of Performance Appraisal Report (PAR) and fulfilment of the following conditions:-
 - The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint 1. account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
 - The institution shall comply with the various other norms and standards prescribed in И. the NCTE Regulations, 2014 as amended from time to time.
 - The institution shall make admissions only after it obtains affiliation from the 111. examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

The institution shall ensure that the required number of academic staff duly approved IV: by affiliating body for conducting the course should always remain in position.

- **12.** The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 13. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
 - a. Sanctioned programme(s) along with annual intake in the institution:
 - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c. Name of faculty members who left of joined during the last, quarter:
 - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e. Fee charged from students;
 - f. Available infrastructural facilities;
 - g. Facilities added during the last quarter;

 - j. The institution shall be free to post additional relevant information if it so desires
